NOTE TO MEMBERS

Because of space and budgetary considerations, the 10 pages of amendments to the Long-Range Plan are not able to be included in The Buckeye. Instead, the decision has been made to utilize other ways to make sure that all members are aware of the proposed amendments. Ohio President Evelyn Bachman has come up with a plan to make sure that all members have an opportunity to review the changes.

They will be made available in the following ways:

1. The document will be put on the website.

2. Copies will be provided to District Presidents. who will distribute them at Legislation Day.

3. The President will mail a copy to club presidents with her convention letter asking that they share the copy with club members.

4. Copies will be available at convention, but members can also bring their copy with them.

5. A copy will be e-mailed to those registered to attend Convention.

2012 OFWC CONVENTION

Can I Vote? And Am I a Delegate or Delegate-at-Large?

Sometimes clubwomen attending the State Convention are required to vote on an issue, motion, slate of officers, etc. It is important that each person know whether she is a voting delegate when completing the registration form for Convention.

Listed below are those persons who are entitled to vote and their specific designation (i.e. delegate, delegate-at-large).

DELEGATES-AT-LARGE

1. OFWC Board of Directors and Junior Board.

2. Those having served in elective offices at state or district level (i.e. state officers, district president, or district director of juniors).

3. Officers and chairmen of the General Federation of Women's Clubs residing in Ohio.

4. All current State Department and Division Chairmen and current District Chairmen.

5. All members of Standing and Special Committees.

6. Trustees of all funds and *The Buckeye Magazine* staff. NOTE: Those members listed above are separate from the Delegates below. It is possible that several members of your club are eligible to vote if you have members who are in the Delegate-at-Large category plus your actual club delegate(s).

DELEGATES

1. Each per capita club of 25 members or less is entitled to ONE delegate (or her alternate).

2. Each per capita club of 26-50 members is entitled to TWO delegates (or their alternates).

3. Each per capita club of 51-75 members is entitled to THREE delegates (or their alternates).

4. Clubs with more than 75 members are entitled to a delegate for each additional 50 members up to a membership of 1,200.

5. Direct members may meet at each Convention and elect one delegate who is also a Direct Member to represent them.

6. Each City-County Federation of 10 clubs or less is entitled to TWO delegates and an additional delegate for every 20 additional member clubs.

The club membership numbers are the numbers of members a club paid dues for by December 31. If you are in doubt, contact your District President as she received the information from the OFWC Treasurer.

Any Delegate or Delegate-at-Large has only one vote even though she may report for more than one club, or be, for example, a district chairman as well as a club president.

If you are not a Delegate or a Delegate-at-Large, you will check the "Non-Voting Member" line on the registration form.

Author of young adult novel to be Saturday speaker

Erin McCahan Richards' wide-ranging experiences and journey have brought her from the third grade when she decided she wanted to be an author to her success in writing young adult books. Her debut novel, *I Now Pronounce You Someone Else*, has won several awards. Erin will be the Saturday Luncheon speaker at Convention.

She was born in Grand Rapids, Michigan, but moved to Columbus when she was nearly five. That's when her mother remarried, four years after her father was killed in Vietnam, and her new stepdad, a Southern gentleman and a surgeon had just joined a practice in Columbus. Erin worked a couple of summers in his office during college and she says how much fun that was. He was a colon-rectal surgeon.

She says she transferred undergrad school so many times she lost count, but spent her best collegiate years at Hope Col-



lege in Holland, Michigan, and Capital University in Columbus, where she still lives. She graduated from Cap with a degree in Professional Writing. And she ended up with a religion minor because of one completely fascinating professor. Erin says, "I just kept taking his classes. He literally was one of those bearded, old-Volvo-driving, hang-out-for-hours-with-students kind of profs who really did change lives. He changed mine. "

Erin explained, "I ended up going to seminary because of him, mostly studied Hebrew and Greek and loved it, but never felt terribly rooted there — or anywhere until I met this great guy named Tim — so I left and wrote freelance articles for a while. Somehow, accidentally, actually, I ended up as a youth minister. Mostly, I didn't have the heart to say no to the minister when she offered me the job on a Thursday, saying, 'I need someone who can start Sunday.' Only after I accepted did she tell me I was in charge of 12- to 18-year-olds."

During the ten years she did that, she all the while was writing in semi-secret, and her path to publication was long, crooked and filled with the standard miseries of rejection and discouragement. Erin says, "It's all part of the process, one thing leading to another if you don't quit – and I didn't – and I found an agent who sold my manuscript, and here I am an author, something I knew I wanted to be as far back as third grade."

"Oh, and that great guy named Tim? I married him. He's one of the reasons I never quit writing, telling me once to 'write until you run out of pens.' I believe I was sitting on the kitchen floor crying at the time, holding my latest rejection letter and muttering something about just getting a job at J. Crew. His enduring support and belief in my ability everlastingly overwhelm me. That's why, no matter what the dedication page says, all my books will always be for him."



The following Resolution is proposed for amendment (added Whereas in bold face type and deletion has strike throughs)

RESOLUTION PROPOSED FOR AMENDMENT

Emergency Resolution 01-01 OHIO COALITION FOR SAFE HIGHWAYS (Reviewed 2008; Amended 2004)

WHEREAS, Big trucking companies and their allies are pushing to end the current "freeze" on the expansion of longer combination vehicles, double and triple trailer trucks up to 120 feet long. The same interests want to increase the weight of current single tractor trailer trucks from the current 80,000 pounds to as high as 97,000 pounds; and

WHEREAS, According to a U.S. Department of Transportation study, longer combination vehicles (LCVs) cause highway safety issues including being more likely to have fatal accident involvement rates at least 11% higher than today's single tractor trailers; and

WHEREAS, Bigger and heavier trucks increase braking distances and reduce maneuverability; and

WHEREAS, States are currently able to bypass a large number of federal regulations as these laws only cover federal highways, and there is a need for legislation to extend to state and local roadways; and

WHEREAS, Larger combination vehicles currently operate in 21 states and one 80,000 pound truck equals 9,600 cars in damage to highways and infrastructure; and analysts estimate that \$326 billion in infrastructure costs to taxpayers will be saved over the next twenty years if pending legislation is adopted; and therefore

WHEREAS, One quarter of the bridges in the United States are rated as structurally deficient or functionally obsolete and are more than 40 years old; and

WHEREAS, According to USDOT, nationwide operation of LCVs would add \$53 billion in new bridge construction costs and \$266 billion in lost time and extra fuel burnt by auto drivers delayed in traffic because of bridge work; therefore

RESOLVED, That, as members of the Ohio Coalition for Safe Highways, the GFWC/Ohio Federation of Women's Clubs supports the advocacy efforts of the Ohio Coalition for Safe Highways; and further

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urges its members and member clubs to contact their legislators, informing them of our support of legislation for the continued "freeze" on the length and weight of trucks on the highways.

The Resolutions Committee also recommended that Resolution 3-04 Gynecologic Cancer be reviewed next year when newer data are available.

Standing Rules of GFWC/Ohio Federation of Women's Clubs — Reference to Resolutions

I. General

D. Resolutions remain in effect until rescinded by the delegate body. All resolutions which have been in effect for four (4) years shall be automatically reviewed by the Resolutions Committee for timeliness, change of opinion, etc. Those whose purpose has been accomplished shall be referred to the Annual Meeting (Convention) to be rescinded.

Active resolutions are printed in toto in the Ohio Directory, beginning on page 75 of the Update to the Directory.

Suggestions and/or proposed changes to the Resolutions are to be submitted postmarked by November 15 to the Committee.

Proposed Amendments to the Bylaws of the GFWC Ohio Federation of Women's Clubs

PROPOSED AMENDMENTS

Article II Officers and District Officers, Duties of Officers Section 11. Assistant Director of Junior Clubs

a. The Assistant Director of Junior Clubs shall assume all duties of the Director of Junior Clubs in her absence. She shall be the Junior Board Secretary and the Junior Membership Chairman.

Strike: the Junior Membership Chairman Insert: serve as Dean of Community Service Programs for Junior Chairmen.

To read if adopted: The Assistant Director of Junior Clubs shall assume all duties of the Director of Junior Clubs in her absence. She shall serve as Junior Board Secretary and Dean of Community Service Programs for Junior Chairmen.

Rationale: Serving as Dean will give her more experience with the Junior membership and with their programs and projects. She will also work more closely with theFirst Vice President/ Dean of Community Service Programs.

d. The Director-elect of Junior Clubs shall appoint the Junior Community Service Program Chairmen subject to the approval of the Junior Board and the GFWC/Ohio Executive Committee at its Post-Annual Meeting (Convention).

Insert after Chairmen: the Junior Membership Chairman, the Junior Leadership Chairman, the Juniorettes Chairman, the GFWC Junior Special Project Chairman, the Communications and the Public Relations Chairman

To read if adopted:

d. The Director of Junior Clubs-Elect shall appoint the Junior Community Service Program Chairmen, the Junior Membership Chairman, the Junior Leadership Chairman, the Juniorettes Chairman, the GFWC Junior Special Project Chairman, the Communications and the Public Relations Chairman subject to the approval of the Executive Committee at its Post-Annual Meeting (Convention).

Rationale: The membership chairman's focus should be the heart of the membership within the organization, not an officer's duties and should be listed with the appointments.

Article X Nominations and elections

Section 3. Eligibility of candidates:

A candidate for the office of Assistant Director of Junior Clubs shall be an active member of a per capita Junior Club, and shall have served on the Junior Board, namely as an elected officer or as a department or special committee Junior Chairman Insert after Club: shall have served as a Club President

Strike "department" and insert Community Service Program.

• THEY LOVE THEIR PIGGY BANKS — When the Bowling Green Women's Club project to raise funds for the March of Dimes was completed by contributing money to piggy banks each meeting, the banks were sought after by members. They had to pay \$1 for a bank, with those funds going for Clubhouse maintenance/repairs. The March of Dimes project raised \$2,354.60, 102 percent of the Clubs goal of \$2,312. The goal had been set when Joan Gordon had the idea of collecting enough dimes to lay side by side around the block where the Clubhouse is located.
