2014 OFWC CONVENTION Can I Vote? Am I a Delegate Or Delegate-at-Large?

Clubwomen attending the State Convention are participating in the annual business meeting of the GFWC/Ohio Federation of Women's Clubs. Each club has at least one vote on the issues that are presented before the assembly. Know if you are a delegate or a delegate-at-large and may vote.

DELEGATES

- 1. Each per capita club of 25 members or less is entitled to ONE delegate (or her alternate).
- 2. Each per capita club of 26-50 members is entitled to TWO delegates (or their alternates).
- 3. Each per capita club of 51-75 members is entitled to THREE delegates (or their alternates).
- 4. Clubs with more than 75 members are entitled to ONE delegate for each additional 50 members up to a membership of 1,200.
- 5. Direct members may meet at each Convention and elect ONE delegate who is also a Direct Member to represent them.
- Each City-County Federation of 10 clubs or less is entitled to TWO delegates and ONE additional delegate for every 20 additional member clubs.

DELEGATES-AT-LARGE

- 1. OFWC Board of Directors and Junior Board.
- 2. Those members having served in ELECTIVE offices at state or district level.
- 3. Officers and chairmen of GFWC residing in Ohio.
- 4. ALL CURRENT State and District Community Service Program chairmen.
- 5. ALL members of Standing and Special Committees.
- 6. Trustees of all funds and The Buckeye staff.

NOTE: It is possible that members are in both categories, but only one vote per member is allowed. Have clubs decide before registering who will be the club delegate and vote the club's wishes.

*If you are not a delegate or delegate-at-large, you will check the "Non-Voting Member" line on the registration form.



The vision statement of HOBY is to "motivate and empower individuals to make a positive difference within our global society, through understanding and action, based on effective and compassionate leadership." The HOBY mission is to "inspire and develop our global community of youth and volunteers to a life dedicated to leadership, service and innovation."

Joining Donna on the podium will be HOBY alumni Sara Whitestone and Austin Pearson who both went through the HOBY program as high school sophomores and have continued their volunteer service ever since.

RESOLUTIONS

The following report was presented to the OFWC Board of Directors in January. There were 12 resolutions that needed to be reviewed.

Six resolutions were reviewed and found to need no changes.

- 2-78 Reclaiming Decent Values in Family Television
- 3-95 Disaster Preparedness
- 2-99 Habitual Sexual Offenders and Sexual Predators
- 1-00 Fiscal Responsibility of GFWC
- 1-03 Long Term Care
- 2-03 Promoting the Study of the History of the United States of America

Three resolutions were found to have met their accomplishments and are recommended to be rescinded.

Resolution 1-02 SAFER SKIES/DOMESTIC AIR-LINE TRAVEL

(Reviewed 2006; Amended 2010)

WHEREAS, The United States of America is no longer safe from attacks by terrorists and saboteurs, and

WHEREAS, Airports are currently installing new scanning technology not only for baggage and cargo but also for passengers. These new scanners which range from full body scans, pat down searches, iris scans, three dimensional photos, microchip embedded passports, machines that blow a puff of smoke to see if you are carrying explosives, and

WHEREAS, All checked and carryon luggage are now scanned and/or hand searched, and

WHEREAS, The government is now establishing a safer and more efficient air traffic system, improvements to the New Air Navigation System and improved airports in order to provide safe airline travel; therefore

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs asks its member clubs to urge their legislators to make it compulsory that all baggage are checked on all domestic and foreign flights and that the screening of passengers be thorough.

RATIONAL: Because of Homeland Security, there are laws and restrictions that provide safe air travel

Resolution 2-02 OHIO WATERWAYS PURIFICATION

(Reviewed 2006, 2010)

WHEREAS, The Ohio Environmental Protection Agency acknowledges that 881 lakes and streams in Ohio are contaminated by mercury from air pollution, and made dirty by agricultural runoff, factory discharges, construction-site debris, trash dumping and mine run-off; therefore

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urges its member clubs to support legislation allocation enough money to develop and implement a plan allowing the Ohio Environmental Protection Agency to purify Ohio's polluted waterways.

RATIONAL: The Ohio EPA Division of Surface Water is responsible for restoring and maintaining the quality of rivers, streams and lakes through the Federal Clean Water Act of 1972 which is funded by federal, state and discharge fees.

Resolution 1-10 DRIVING AND TEXTING

WHEREAS, Driver distraction was fatal to 6,000 persons and injured a half million more last year, and

WHEREAS, Texting has been shown to be the worst distraction because of the danger when texters (those who are texting) are looking down and not devoting attention to driving, and

WHEREAS, Text messages rose from 10 billion in 2005 to 110 billion in 2008, and

WHEREAS, One in four people admitted to texting while driving and 46 percent of teenagers say they text while driving, and

WHEREAS, 18 states have passed laws making texting while driving illegal, and

WHEREAS, Some Ohio counties and cities like Summit county and Cleveland have bans against reading or sending texts while driving, and

WHEREAS, Bills have been introduced in the Ohio House of Representatives (HB 270) and the Ohio Senate (SB 160) to ban texting while driving statewide, therefore

RESOLVED, That members of the GFWC/Ohio Federation of Women's Clubs contact their state legislators to advocate for the passage of these bills for statewide coverage, and further

RESOLVED, That GFWC/Ohio Federation of Women's Clubs members educate other community members and increase their awareness of the dangers of driving while texting and encourage them to contact their legislators to urge passage of the bills.

RATIONAL: Ohio passed a law against driving and texting effective August 31, 2012

The following are the Resolutions that need to be revised and the proposed amendments. Items to be deleted are strikethrough and the proposed changes are in bold print.

Resolution 1-95 PROSTATE CANCER SCREEN-ING

(Reviewed 2003, 2007; Amended 1999, 2010)

WHEREAS, One (1) in six (6) men has prostate cancer

in some form by the age of fifty, but only one (1) in thirty-five (35)thirty six(36) will die from it, and 238,500 men will be diagnosed this year and

WHEREAS, while thirty-five (35) percent of those curable were detected by DRE (direct digital rectal exam), the cure rate increases to eighty (80) percent by the concurrent use of PSA (prostate specific antigen) blood testing; therefore

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urges members to encourage their male friends and relatives to obtain annual DRE and PSA testing beginning at age fifty (50) or as recommended by their physician, encourage proactive measures by continuing to monitor PSA for signs of trouble; and further

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urge member clubs to become involved in community education (formally or informally) about the importance of DRE and PSA testing. Members are encouraged to form a coalition with hospitals and the cancer society to present programs, promote testing opportunities and form support groups for prostate cancer patients and for their relatives and friends.

RATIONAL: New data published by American Cancer Society and the National Cancer Institute

HOUSEKEEPING: Change DRE to read (digital rectal exams)

Resolution 2-95 BREAST CANCER SCREENING (Reaffirmed 1999; Amended 2003, 2007, 2010)

WHEREAS, 2.4-2.8 million women in the United States have been diagnosed with breast cancer and breast cancer is the most common cancer among U.S. women and accounts for one (1) out of every four (4) women diagnosed. And 192,370 **232,240** more women will be diagnosed this year and an estimated 1 million women are unaware that they have the disease, and WHEREAS, Breast cancer is the 2nd leading cause of cancer death for women in the United States between the ages of 20 and 59, a woman in the United States has a one (1) in eight (8) chance for developing invasive breast cancer during her lifetime; and the chance that breast cancer will be responsible is now 13%. Death rates from breast cancer are declining significantly with the largest decrease in young women; this is attributed to early detection, and more effective improved treatment, and possibly decrease incidence as a result of declining use of menopausal therapy, and

WHEREAS, About 77% of breast cancers occur in women ages 50 and over and although less than 5% of all breast cancer occurs in women under the age of 40, younger women who develop breast cancer have a lower survival rate, and

WHEREAS, Mammogram screening does not prevent

or cure breast cancer; however, it may detect the disease before symptoms occur because breast cancer can exist six (6) to ten (10) years before the growth can be detected; therefore

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urge each member to learn and practice monthly self-breast examinations and to have clinical breast examinations every three (3) years for women 20-39 and every year for women 40 years or older or upon recommendation of their physicians; and further

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs encourages its members and other women to continue self-breast examinations as a way to reduce risk factors and to follow medical community guidelines for finding cancer early since it is non-invasive, does not cost anything and has been effective in some instances.

Rational: New data published by the American Cancer Society and the National Cancer Institute

Resolution 1-99 ORGAN DONATION

(Amended 2002, 2007, 2010)

WHEREAS, According to Lifeline of Ohio ® a nonprofit organization which promotes organ donation, there were 100,000 120,000 individuals on the national waiting list for an organ transplant as of December 2009; October, 2013 and

WHEREAS, On the average 18 individuals (men, women, children) on the national waiting list die each day while awaiting a transplant, and

WHEREAS, One donor can save or improve the lives of seven (7) eight (8) individuals awaiting organ transplants and 35 to 50 awaiting tissue transplants, and one tissue donor can enhance the lives of more than 50 people and

WHEREAS, 90% 80% of Americans say they support organ donation but only 30% 52% sign up to do this; therefore

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urges its member clubs to present programs to educate members and the public on the benefits of organ donation, answer questions concerning donations and to learn how to become a donor.

RATIONAL: New data published by Life Line of Ohio and LifeBanc of Cleveland

HOUSEKEEPING:

Resolution 2-03 PROMOTING THE STUDY OF THE HISTORY OF THE UNITED STATES OF AMERICA

(Reviewed 2007, 2010)

WHEREAS, The United States of America has always led the way with cultural change, human enrichment

and worldwide enlightenment, and the influence the United States of America has in the world is unequaled in history; and

WHEREAS, Children and young adults in particular and people in general in this country are woefully ignorant of the history of the United States of America; and

WHEREAS, The schools of this country generally have pushed history education to the background of their curricula in favor of more "marketable" courses such as math, science, business and vocational education; and WHEREAS, President George Bush has called for a renewed emphasis on learning the history and place of the United States of America in the world; therefore RESOLVED, That the GFWC/Ohio Federation of Women's Clubs and its member clubs and members shall encourage their local school systems to place more emphasis on the study of the history of the United States of America in their curricula; and further

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs members and member clubs shall assist the schools in informing the students about the need for their participation in government and the awareness of their unique place in history, thus increasing their pride in their common heritage and in the diversity encompassed by the United States of America: and further

RESOLVED. That the GFWC/Ohio Federation of Women's Clubs members shall undertake to provide programs and projects that promote knowledge and awareness of the history of the United States of America both for their clubs and their communities; and further

RESOLVED. That the GFWC/Ohio Federation of Women's Clubs members shall show their pride in their country by voting, serving in public office and/or the military, participating in public discussions, honoring the Flag of the United States of American and observing patriotic occasions with special focus on the history that led to the observance and the importance each one holds in the developing history of the United States of America.

RATIONAL: Bring it to the proper tense

NEW RESOLUTION

1-14 SHOP LOCALLY

WHEREAS, According to the latest U.S. Census findings, about three quarters of all U.S. business firms have no payroll, most are self-employed persons operating unincorporated businesses, and may or may not be the owner's principal source of income; and one quarter of all U.S. business firms have under 10 employees; and

WHEREAS, The Small Business Administration Office of Advocacy funded data and research shows that

small, independently owned businesses represent 99.7 percent of all firms, create more than half of the private non-farm gross domestic product, and 60 to 80 percent of the net new jobs; and

WHEREAS, The "Local Works!" study found that for every \$100 spent in locally owned independent businesses \$68 returns to the community through taxes, payroll, donations to local charities and other means and only \$43 stays in the community from national chains and nothing stays in the community for online purchases; and

WHEREAS, the study also showed that shopping locally reduces urban sprawl, congestion, habitat loss and pollution; a more efficient use of public services, and that skilled workers are more likely to invest and settle in communities that preserve their one-of-a-kind businesses and distinctive character, and

WHEREAS, The New Economics Foundation found that by shopping locally owned businesses consumers keep their communities from becoming areas devoid of shops, maintains local store diversity and character, circulates money more quickly throughout the community; therefore

RESOLVED, that the GFWC/Ohio Federation of Women's Clubs members support independently owned local businesses by consciously shopping local first; and further

RESOLVED, that the GFWC/Ohio Federation of Women's Club support "shop local" programs and legislation to support small businesses.

Monday is for Membership and Membership Matters messages have been sent across the state to district chairmen and club presidents.

The GFWC Ohio Board researched and approved a computer program to help develop the member database.

A new Ohio program was offered to reward the members and the clubs, who recruited new members, with cash. Star Recruitment Awards, the GFWC Season Recruitment Campaign, membership grant deadlines and program samples were shared at workshops, dis-

trict meetings, in print to help the clubs with ideas and encouragement. We are excited to announce that we have surpassed our goal of recruiting 125 members by 56 for a total of 181 NEW MEMBERS. We are proud to share that we have had a NET increase in our membership for the first time in many years. We went from 1245 to 1273 GFWC Ohio members. We are also thrilled to share that TWO new clubs were formed.

Leadership Update

GFWC Ohio will continue to develop and share leadership materials through the 2014-2016 Administration. The goals were met for 2012-2014 by continuing with GFWC Ohio's State Federation Leadership Day and our Leadership Training Workshop for the incoming District Presidents and District Junior Directors for the 2014-2016 Administration. Five of our GFWC LEADS Graduates led their own mini workshops at State Leadership Day.

Leadership materials have been available to the members of GFWC Ohio through our State Directory, Website, and by District Officers and Chairmen sharing these materials at District Meetings.

Leadership Training Programs are being developed for the incoming 2014-2016 Administration and will be conducted at a pre-Convention workshop in April, 2014.

Communication & Public Relations Update

Communications

"Skyping" has been the popular media concept for the 2012-2014 Administration and many Clubs have had the honor of "sharing Skyping" with the GFWC Ohio President for the very first time. All attendees at the 2013 GFWC Ohio Convention were able to participate in a Group Skype. The GFWC/Ohio Federation of Women's Clubs has an active and up to date Facebook Page that promotes great exposure and advertising across the country and with multiple GFWC clubs on current programs, projects and events that have been successful and a lot of fun!

The Buckeye Magazine is a great Federation communication tool and continues to reach out to GFWC Ohio clubs and members with articles focusing on Leadership, Membership, and Communications four times per year, along with wonderful programs, projects, and events.

A computer program has been approved and put into place by the GFWC Ohio Board to refine and utilize a Membership Database. There is still the need to develop an additional database of at least one member in every club to be the electronic liaison. The GFWC Ohio Board approved the procedures and criteria developed by a committee chaired by the Second Vice President, for the use of electronic E-Blasts when appropriate. An E-Blast Chairman will be appointed for the upcoming administration to facilitate the E-blast distribution. This project will ensure more outreach and sharing of information to all members

The unveiling of the GFWC Great Lakes Region Newsletter, "The Tattletaler" has kept larger numbers of clubs and members "in the Federation Loop," and is a great example of an electronic communiqué. The

GFWC Great Lakes Region Newsletter can be found on our GFWC Ohio website.

The GFWC/Ohio Federation of Women's Clubs Website has and continues to be a great resource for members to download forms, scholarships and a bevy of useful information. Our top notch Website Administrator keeps it updated and easy to use.

Public Relations

The GFWC/Ohio Federation of Women's Clubs "Action Plan" continues promoting public awareness of our premier statewide volunteer organization. Different facets of the multi-media public relations campaign have unfolded including encouraging and showing GFWC Ohio Clubs how to develop and maintain a website, as well as linking club websites to both GFWC and GFWC Ohio websites to create and promote more awareness for Federation Fun, programs and projects. More planning would be wonderful to continue to educate more members and clubs on how to develop a website and/or a GFWC Ohio Club Facebook Page through Convention workshops, Fall Conferences and Leadership Day activities including a "hands on" training session for one on one club learning.

Many clubs have "jumped on the bandwagon" by using GFWC in their club name, events, media, advertising, meetings, exhibits and local newspapers. Members have made it a point to use the proper and updated GFWC logo for branding usage and identity purposes. GFWC, GFWC Ohio and club logo wear is encouraged for all Officers, Chairmen and Clubwomen to wear at meetings, events and functions. At the GFWC/Ohio Federation of Women's Clubs Annual Convention, club logo wear is proudly worn on the closing day to show Federation Pride! GFWC Ohio Fundraising items are always for sale and available to purchase during Convention, District meetings and through individual clubs across the state. Our GFWC Ohio Fundraising and Junior Fundraising Chairmen are very proactive in getting these items out there and sold. Ohio Clubwomen continue to display their GFWC Banners and Flags, as well as Emblems very proudly and passionately.

Financial Stability

To ensure that current member benefits and the needs of the Federation are met, GFWC/Ohio Federation of Women's Clubs continued to cut costs and raise non dues generated revenue including selling vendor space at the Annual State Convention and applying for grants. (Continued from Page 21—"What Do You Do With New Members) club meeting—come as the club's guest. The theme... try us for free!

- Give some form of appreciation to those who get involved.
- Every time a person gets involved in your association someone needs to say, "Thank you!"
- Recognition for involvement is an important factor in getting people to come back year after year and be involved again.
- Personally acknowledging individuals during a club meeting is a great way to show appreciation, as is including their names in the club newsletter or website. (Not all seek public recognition, but everyone likes to at least be thanked for their efforts.)

Don't wait until the end of the year to give awards and thanks to those who were involved.

Reason for joining? Try to identify as clearly as you can why people are joining. Keep track! Be sure to understand what benefits members want as they are joining and reinforce those benefits early in their first year of membership.

Develop an effective renewal process.

• Prior to renewal, send a cover letter, an annual message from the president, or a list of recent accomplishments because it reminds members how their money has been spent during the previous year and suggest that the association can do this for members again next year if they renew.

For the first time in as many years as our records and GFWC records allow us to see GFWC Ohio had a net gain in their membership numbers! According to records received by our treasurer we had a net gain of forty-four new per capita paying members – wonderful! Hopefully the GFWC Ohio Membership Initiative inspired a few to recruit and if it did remember in order to get money for your wallet you received last year you must complete the STAR recruiting form and send to the GFWC Ohio Membership Chairman, Rose Logston, as soon as possible!!

Since we do have some new members (two hundred and fourteen) now what do we do with them to get them engaged and then keep them engaged? Here are some ideas (taken from a GFWC resource – benefits of belonging) that might help you in that endeavor and remember your membership team is always available.

What Do We Do With New Members? By Rose Logston, GFWC Ohio Membership Chairman dies indicate that first- and second-year members are the most likely to drop out of membership organic

Studies indicate that first- and second-year members are the most likely to drop out of membership organizations. Studies also show that new members are very enthusiastic soon after joining and their decision to remain with an association is typically made during this time. What does this tell us? **Get members involved early!**

Below are tips and ideas to consider that will assist you in new member retention and engagement within your club.

Focus on new members. Your club needs to let new members know that they are special and that their membership is appreciated.

- Welcome each new member personally. This can be done by a phone call from a designated club member, mentor, or new member coordinator. It's also useful if the caller can tell the new member what a good investment membership has been for them and congratulate the new member on making a great decision to join. This helps the new person feel more welcome and it validates membership.
- Special recognition in club newsletter or website (everyone likes to see their name in print).

Present a membership certificate to hang up so people know they've joined. Provides a sense of belonging and recognition.

Contacting new members. Contact new members frequently, but without inundating them with too much information. Tell them from the start that they are special members and that over the next few months they will be receiving information. If they have any questions, provide them with a contact person to get answers. An example of what could be performed in addition to regular communication throughout the year includes:

- Initial contact within the first 30 days of joining.
- Contact them personally twice (why twice? Once is nice, but twice is impressive) within the first two months. Send a mini-survey to members six months after they join to see how they rate your club's service (i.e. six month report card). Questions could include: Is club meeting start time convenient? Is meeting frequency appropriate for our club? How can we improve our club? Club meetings?

Mentors and New Member Coordinators. To assist in contacting and welcoming new members to your club, consider establishing a mentor program. You may even wish to create a new position within your club that's specifically aimed for new members, and this could be referred to a "New Member Coordinator." Mentors and New Member Coordinators are very important since they'll probably have the first contact with new and potential members. As presumed, both need to know the club well and like interacting with people.

- New member orientation. Don't assume new members will automatically have the skills and experience necessary to fully participate in club meetings or serve on the board. All new members—both young and old—should have the option to receive training or an orientation.
- Utilize mentors or New Member Coordinators (if any).
- Provide new members with a membership kit or brochure highlighting club information, opportunities for involvement and activities.
- Provide new members with the history of the club, previous issues, past actions taken, and other useful information.
- Orient new members to lingo that may be used at club meetings or by the board. New members may also not have previous experience with business meeting etiquette or procedures.

Be patient! New members may have a steep learning curve and will need time to adjust.

New member involvement. Research tells us two things: 1) people like to be asked to volunteer and be involved, so personally ask them, and 2) when individuals get involved in the activities of your organization, it is less likely that they will drop out because they view their involvement as an additional way to get a return on their dues investment. Be careful not to equate involvement with leadership. It is unlikely that all your members will be involved at that level, therefore think of involvement as participation in activities, as well as leadership in the club.

Invitation to meetings; encourage attendance. Just as with involvement, members like to be asked to attend meetings, particularly early in their membership. New members may need a bit of encouragement to attend a meeting or function since they're not yet familiar with the club or its membership. Note: This may also be an effective recruitment tool. Extend to non-members or prospective members a special invitation to the next (continued on page 20)




