New rules apply; dogs may be entered multiple times, different levels as well. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or electronically. **Make check payable to WDDMV**. Send entries & fees to the trial secretary. Dogs do not need to have a Barn Hunt registration number for a Fun Test.

Pre-Entry fees are \$10/class Limit 75 runs total. Late entries and day of entries may be accepted if space allows. Late entry fees are an additional \$5.00 per run.

DIRECTIONS TO TRIAL SITE:

Business VA7 Round Hill exit, to Evening Star Dr to State RT 719, make the 1st left after the one lane bridge onto State Rt 713 (Appalachian Trail) right onto Southern Cross Lane, follow signs

This event will be held outdoors – rain or shine! Please dress appropriately!

All dogs must be on lead and under control while on the trial grounds. **FLEXI LEASHES ARE NOT PERMITTED in the fun test area. Dogs MUST run naked, no collar or harness.** There is **NO SMOKING except in your vehicle..** Please pick up after your dog and dispose of waste in designated areas.

RUNNING ORDER:

Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. **No more than 75 runs will be accepted.**

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs, must wear panties and will be run at the end of their class/trial. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

Class Descriptions:

RATI (Rat Instinct Class): Three PVC tubes placed in plain sight on the course. Tubes will be: one dry, one with litter only (no rat), and one with both litter and a rat. Time Limit: 1 minute.

RATN (Novice Barn Hunt): Three PVC tubes hidden on the course. Tubes will be: one dry, one with litter only, and one with both litter and a rat. Time Limit: 2 minutes.

RATO (Open Barn Hunt): Five PVC tubes hidden on the course. Tubes will be: one dry, two with litter only, two with rats and litter. Time Limit: 2 minutes,30 seconds

RATS (Senior Barn Hunt) Eight PVC tubes hidden on the course. Tubes will be one dry, three with litter only, 4 with rats and litter. Time Limit 3 minutes 30 seconds

RATM (Master Barn Hunt) Eight PVC Tubes are hidden on the course, the number of live rats will can with each competitor ranging from 1 rat to 5 rats)
