OUR JULY EVENT GUEST SPEAKER was Mr. Bill Burke, Cultural Resources Program Manager and Historian, Cape Cod National Seashore, a unit of the National Park Service. (For the record, there was a last minute relocation to DiParma Italian Table in West Yarmouth MA due to confusion with Yarmouth House Restaurant.) Bill brought us hand marked Seashore maps plus a stack of color prints. The maps identified the locations where the scenes depicted on the printed sheets occurred. The narrative took us from the Revolutionary War British blockade ship HMS Somerset III which sank near Provincetown in 1778 to the Cold War period Texas Tower long range radar stations which stood guard against Soviet missiles 150 miles off the coast. In this way Mr. Burke reviewed the history of military activity on Cape Cod.

We could have used more than the 21 people who attended. But the fun of the raffle drawing to support the Scholarship Fund went on nonetheless. First time event participants member Col Rob Ricci USAF (ret) and wife Shelly-Raye had their winning numbers pulled a record five times! They graciously returned the excess tickets, giving others the chance to win.

A special thanks goes to Ben and his staff at DiParma Italian Table. They willingly agreed to take over on short notice, provided great meals which led to multiple comments about returning (which we are doing in September) – and even gave a \$50.00 gift certificate for a future raffle.

14 SEPTEMEBER 2021 EVENT - Cape Cod PATH - People Against Trafficking Humans

Human Trafficking is contemporary slavery that involves the exploitation of persons for commercial sex work or compulsory toil. Criminal perpetrators use force, fraud or coercion to compel victims to perform sexual acts or labor services against their will. Cape Cod PATH is a grass-roots task force working to end human trafficking and its risks on Cape Cod, Massachusetts. This mission is



accomplished by raising awareness through education, outreach and collaboration.

Trafficking victims can be any age, race, gender, or nationality. They may be men or



women, young or old, from the U.S. or abroad, with or without legal status. This may involve children in the child welfare and juvenile justice systems, runaway and homeless youth, and people with disabilities or other unusual life challenges including limited proficiency in English - almost anyone can become a victim. Prostitution is the most common form of human trafficking. Victims are typically citizens of any age, but start, on average, at 12 - 14 years. This enslaved population may earn \$500 and up in a day's time, with victims forced into from one to 15 encounters in that period; all the money goes to the pimp.

Inspired by the film screening of "Hidden in Plain Sight" in January 2014, a group of concerned citizens decided to form a task force. Research determined there were no statistics about human trafficking on Cape Cod, with only one organization equipped to help victims cope with the trauma. Knowing estimates run to the tens of thousands of people who are trafficked in this country - millions more globally - organizers aligned national risk factor statistics with local demographic data to establish a level of risk for Cape Cod. PATH's strategic community solutions are informed by this evidence-based assessment and designed for multi-disciplinary collaboration with local partners. Also there is a strong working relationship with a Victim Assistance Specialist in the Department of Homeland Security Investigations. Development of partnerships with local groups continues as the organization grows.

Since its inception, Cape Cod PATH has offered presentations at local libraries, religious assemblies, and schools. It has hosted events such as movie/discussion panels and outdoor vigils, staffed information tables at gatherings, visited Cape lodging locations to distribute flyers and offer staff training. Hundreds of resource bags to assist survivors have been delivered. In December 2019 the Barnstable County Human Rights Advisory Commission awarded PATH its Cornerstone Award for supporting human rights.

Presenter Katie Parache is a twelve year veteran of the Barnstable Police Department and is currently assigned to the Criminal Investigation Unit as a Detective. Det. Parache specializes in victim centered crimes including domestic violence and sexual assault. She also currently serves as a Crisis Negotiator for the Cape Cod Regional SWAT team. Det. Parache has worked on investigations involving human trafficking. Through collaboration with other agencies, both law enforcement and civilian, she works to help victims of this modern slavery.

Presenter Lois Hirshberg has a Master of Education in Community Counseling and a Master of Arts in Expressive Therapy. She was the Guidance Counselor at the Kenneth C. Coombs School (Pre-K through grade two) in Mashpee, Massachusetts, for 17 years. She retired from the Mashpee Schools in 1996 to continue her artistic creativity in ceramics, a passion now more than 40 years old. Even though no longer working as a child therapist, she maintains a strong desire to help children in need. She has been a member of the Cape Cod PATH Task Force for six years and now serves the organization as Treasurer.

Janice Hank has been involved in Cape Cod PATH for about six years, and has been Chair of Cape Cod PATH for four years. After seeing a presentation on Human Trafficking in Wellfleet, she knew she had to get involved and spread the word to other people and organizations on the Cape. As a retired elementary school teacher, the importance of educating the youth and adults about human trafficking on Cape Cod, and the dangers of social media which could lead to sex trafficking, is of the greatest significance to her.

MOAA Sends a Message to Lawmakers on Arlington Cemetery Eligibility Changes

An extended schedule for the FY 2022 National Defense Authorization Act (NDAA) provides lawmakers an opportunity to intervene on planned eligibility changes at Arlington National Cemetery – discriminatory changes that will dramatically reduce the benefit of full military honors.

Your letters, emails, and phone calls are important to change course on the proposed eligibility changes. Staff members with lawmakers from across the country have reached out to MOAA to better understand the issue and develop a solution. MOAA recently sent a letter to leadership on both the House and Senate Armed Services committees, asking them to use the NDAA as a vehicle to direct DoD "to designate the next national cemetery that affords full military honors and to leave unchanged the current eligibility requirements earned through military service." If Congress doesn't act, "the change in eligibility puts the burden of a solution on the currently eligible servicemembers and their families – including those who have long had Arlington as their plan for final rest," wrote MOAA President and CEO Lt. Gen. Dana T. Atkins, USAF (Ret).

Continued engagement from constituents is still necessary. Don't just send an email: call (866) 272-MOAA (6622), MOAA's toll-free line to the U.S. Capitol switchboard, to be connected with your legislators' offices. Sometimes it can take multiple engagements to get through to the correct staff member. Multiple forms of communication can make a real difference: consider sending a copy of your correspondence to the Armed Services Committee leadership in both chambers. Some lawmakers incorrectly believe the problem of Arlington eligibility has been solved and grandfathering was achieved – confusion stemming from a Congressional Research Service report. ANC eventually will run out of room, even with the proposed eligibility change, and an enduring solution is required to ensure our nation will continue to provide full military honors as a benefit. With current eligibility standards, ANC will not run out of room until 2050, leaving ample time to develop the enduring solution. The 2017 ANC report to Congress outlining the

capacity concerns offered a course of action to continue providing the current benefit of full military honors to those now eligible and solve the space problem: Option 3.2.2.3 in the report, shown below, would require legislation to establish a new national cemetery that will afford full military honors at a new location.

ANC, as it operates today, cannot endure forever in its current space. Looking 100-200 years into the future, how and where will we honor our Nation's heroes? Another option, which the Army recognizes would represent a significant change, is establishing a new Department of Defense-run national cemetery in another location. This would mean building a new cemetery in a suitable place that would offer the same burial honors as ANC. While it is impossible to recreate the aesthetic appeal and history of ANC, this new cemetery could grow to become iconic over time, in the same way that ANC has gradually evolved over the past 150 years. Operating ANC as an active burial ground for as long as possible would allow a phase of overlap and continuity while establishing the new space.

MOAA will continue to engage Congress on Arlington National Cemetery, and we need your voice as constituents. Reach out to your lawmakers [email sending link]. Ask them to include language in the FY 2022 NDAA that would require DoD to designate the next national cemetery.
