Scholarship Program

In both May, 2008 and May, 2009 we were able to give \$7,500.00 in scholarships but in May 2010 we could give only \$7,000.00.

It may just be another economic indicator that we are all going through some tough times but the Cape Cod Chapter's Scholarship Account balance is running significantly behind last year at this time. At the close of September, 2009 our account balance was \$2,114.23. This year at the end of September, 2010 our account balance is \$1,612.78.

As most members know our two of the three sources of cash for our Scholarship Account are the raffles at our social functions and donations from our members. The third source of cash for the scholarships is money from dues that the Board deems to be in excess of current cash flow requirements so we donate that excess to our scholarship program.

We will have three more raffles before the May, 2011 Scholarships are awarded and they will be at the November, 2010 luncheon at the Riverway Lobster House, the December, 2010 luncheon at the Radisson, and the April, 2011 luncheon currently scheduled for the Golf Course Clubhouse at Massachusetts Military Reservation. Our raffles usually generate \$200-300 each for our Scholarship Account. Donations made by our members comprises the largest single source of revenue for the Scholarship Account and usually account for 50% of all money we give each year to deserving students. This is why the current balance in our Scholarship Account is so alarming.

Please consider a donation to the Scholarship Account as part of your gifting plan this year. We know there will be another group of deserving students who will be counting on the Cape Cod Chapter to help them in 2011.

AF Base Dining Open to Retirees - Many Air Force base dining facilities have seen use rates drop below 50 percent. Instead of closing these facilities, Air Force plans to open some facilities at six bases to retirees. Retirees will pay the same market price as everyone else, and there will not be an added surcharge on top of the menu price. The six Air Force bases participating in the initiative are Elmendorf AFB, Alaska, Patrick AFB, Florida, MacDill AFB, Florida, Fairchild AFB, Washington, Little Rock AFB, Arkansas, and Travis AFB, California.

A Little-Known Benefit for Disabled Veterans

If you know a veteran who is living in a nursing home or assisted living or requires home care, he or she may be eligible for extra cash. The little-known benefit, called Aid and Attendance, helps to offset some of the costs of care.

The Aid and attendance benefit supplements a veteran pension or other disability benefit. "Any time that someone who is disabled can obtain some additional funds to defray the costs of health care, it is beneficial," says Gerald Manar, an executive at the Veterans of Foreign Wars.

Veterans receiving compensation for a disability resulting from military service, such as the loss of limbs, don't have to meet financial criteria. They can receive up to \$3,327 a month in aid, or more if they have dependents, says Kerry Baker, chief of legislation and policy with the Department of Veterans Affairs.

A benefit is also available to wartime veterans who may be eligible for a veteran pension. They and their surviving spouse must meet an income test. To qualify, "they must need another person to attend to their needs of daily living," says Baker. For example, a veteran or surviving spouse who suffers a stroke and needs help dressing and eating could get the benefit.

To determine eligibility, you would reduce the veteran's income by the medical costs not covered by insurance. If that amount is \$19,736 or less, a single veteran with no dependents could be eligible for Aid and Attendance.

The maximum monthly benefit is \$1,645. Your benefit is based on the difference between the income limit and your after-expenses income. For example, if your income is \$25,000 and you pay \$10,000 in medical expenses, you'll get an annual benefit of \$4,736.

Veterans can get an application from the Department of Veterans Affairs (www.va.gov; 800-827-1000). You can also get help from a veterans group to fill out the application. KATHRYN A. WALSON, KIPLINGER'S RETIREMENT REPORT, August 2010.

Another source states that in 2009 only 105,000 were using this benefit and as many as 2.3 million veterans may be eligible.
