ON 14 OCT 14 Chapter members and friends were guests of CAPT John T. Kondratowicz USCG, Commander, <u>USCG Sector Southeastern New England</u> at the <u>Woods Hole</u> Sector location. The lunch and tour event was detailed by CDR Carissa April USCG, Sector Logistics Department Head and Commanding Officer of Military Personnel. CDR Richard Schultz USCG, Sector Deputy Commander, was present to add to the welcome. A meal of grilled burgers and dogs with all the trimmings was the special consideration offered by the Woods Hole Chief Petty Officers Association. Tour features included boarding USCGC Sanibel, a briefing at the Sector rescue and response command center located in the headquarters building, a talk and boat boarding at the USCG Station Woods Hole pier, and an explanation of the operations of the Woods Hole ANT (Aids to Navigation Team). Registration was a robust 46 and the weather cooperated. <u>09 DEC 14 EVENT – PROGRAM</u> Our presenter is Chapter member Lt Col Dwayne Turmelle USAF, currently the Case Manager for the Supportive Services for Veterans Families (SSVF) program at the Cape and Islands Veterans' Outreach, Hyannis, Mass. The SSVF program helps very low and extremely low income veterans and their families remain stably housed or acquire permanent housing by providing money to landlords, utility companies, moving companies, and licensed child care providers. Dwayne will share about the new Grace Veterans Center approach to veterans support. He has been at the Cape and Islands Veterans Outreach for the past four years. During that time he has served as the Homeless Veteran Housing Coordinator and as the inaugural Director of Operations for the Grace Veterans Center in Mashpee, Mass.

Prior to his stint at the Outreach Center, Dwayne received his commission through the Air Force Reserve Officer Training Corps in 1983 while earning a Bachelor of Arts degree in Political Science from the University of Massachusetts-Lowell. In 1996 he completed a Master of Arts in Human Resource Management from Webster University in St. Louis, Missouri. He anticipates graduating in winter 2014 from Suffolk University in Boston with a second Masters degree, this one in Public Administration.

Upon completion of his active duty service (1983-2004), Dwayne retired in the rank of Lieutenant Colonel. During his Air Force years he served in several capacities, most notably as a Titan II and Peacekeeper Nuclear Inter-continental Ballistic Missile (ICBM) Combat Crew Commander; as Chief, ICBM Operational Test and Evaluation; as Military Advisor to the Assistant Secretary of State for Intelligence and Research; and as Commander, Detachment 475, at the University of New Hampshire.

Dwayne resides in Monument Beach, Mass., with his wife of 30 years, Michelle, and faithful golden retriever named Remy. In his spare time he coaches the college club hockey team at Northeastern University in Boston, and plays golf all over Cape Cod.

IN MEMORIAM (belated) Former Chapter member and USN WAVES Lieutenant Marie Reed Baldwin Wasem, 91, of Harwich MA and Sarasota FL, born 13 Nov 21 in Perry Point MD, died 22 Jan 13 at Rosewood Manor, Harwich. Marie described growing up with her siblings during the Depression as an idyllic childhood "making their own fun." She was valedictorian of her high school class and attended Western Maryland College, now called McDaniel College. She

left after her junior year during World War II to joined the WAVES. She was sent to Smith College for training and to Oklahoma for cryptography where it was discovered she had a photographic memory. She was then posted to Norfolk Naval Shipyard where she memorized all berth specifications and the requirements for every ship. Knowing this data, as vessels arrived she transmitted to the ships' captains an available location in code. She told funny stories about Navy captains who did not want to take orders from a female officer.

In Norfolk she met Edgar F. (Dick) Wasem Jr., and married him five months later. Due to D-Day preparations the wedding was postponed from June 5 to June 7, 1944. The couple raised four daughters, Pam Rose, Ithaca NY, Penelope Wasem, Harwich, Kirby Yoshii, Tokyo, Japan and Edgewater MD, and Karen Wasem, Minneola FL. There are five grandsons and two great-grandchildren. Raising a family in the Navy and hosting foreign students led to many friends around the world. Marie loved entertaining and often cooked sumptuous meals for a crowd. She found places to volunteer wherever the family moved as she wanted to help others.

Burial was at Arlington National Cemetery, June 2013. Memorial donation checks to the Navy-Marine Corps Relief Society should be payable to NMCRS with the memo line stating: in Memory of Marie Wasem. [from *Cape Cod Times* and Doane, Beal Ames Funeral Home]

<u>TV WATCH</u> Retired <u>Naval Criminal Investigative Service</u> Special Agent Leon Carroll, Jr., is technical advisor to CBS TV's *NCIS*, now in its twelfth season. Here are excerpts provided by <u>member Tom Keating</u> from a fall 2014 CBS fan magazine interview with Carroll.

"Back in 2003... I was looking at retiring, and they... asked if I'd be interested in... a few days a week. I had a meeting with Don Bellisario and he hired me. The rest is history.

"[My first day in the TV business] was totally different.... I thought we were going to shoot the whole episode in one day.... So about 12 hours in, I started looking at my watch and finally one of the sound guys came over to me and said, 'Hey, I see you looking at your watch all the time. You're going to drive yourself crazy. It's over when they say "wrap." '.... [Doing actual NCIS work] you sit on a stakeout and it's obviously boring, because you're watching and waiting for something for hours on end, but once it's over you go out and do other things. You don't constantly do that day after day. I had worked longer hours at one time for the real NCIS – I think 36 hours is the longest I'd worked without having a break – but that first 19-hour day of NCIS in 100-degree heat was definitely an eye-opener.

"[My input] begins with the scripts and... outlines. [At] first... it would be too late to really change things, so I started getting involved at concept meetings. Now I... sit with the writers. By the time we get to the set... if I've done my job..., there's not a lot left to question.

"A question recently came up on the set for a scene where McGee is going into a suspect's backpack. It was one of those spur-of-the-moments where the suspect consents; the agents weren't out looking for evidence. Normally, agents don't just walk around with gloves, but the scene was depicting one of those times where any good agent would ask himself, 'Should I touch this with my bare hands? Or should I put on a glove?' We made a decision to have McGee pull a glove out of his pocket as though he carries one all the time.

"[After twelve years doing this,] I don't know if we can get any of these [actors and writers] to think like NCIS agents. But at least they know what the proper procedures are better than in Season 1. And I've learned a lot about what the camera's looking for —... looks and lighting and things like that.... I don't think that our actors, with maybe a couple of exceptions, would want to be agents."

[Which still begs the question of why there continue to be so many uniform appearance and shipboard procedure errors in the finished product. Editor]
