HAT we learn at conventions to make our clubs better can be categorized into two parts—that informal exchange of ideas with other club members and the group of learning sessions we call workshops. Later Friday afternoon, Patrice Booze, GFWC Membership Chairman, will help you "Plant the Seeds of Good Membership." A blooming Membership Garden is a thing of beauty and doesn't just happen. Climates change and so do members and clubs. Doing things the way they have always been done may no longer reap the rewards they once did. Participants will be given the tools needed to take an honest look at their club's retention and recruitment Strengths, Weaknesses, Opportunities, and Threats (SWOT).

Missi McCoy, GFWC Director of Junior Clubs, has been a member of GFWC for nearly three decades, and currently is a member of GFWC/KFWC Somerset Junior Woman's Club. She has served GFWC as Public Affairs Citizenship Chairman, GFWC Junior Identity Committee Chairman, and twice as Kentucky Director of Junior Clubs.

Within her state and region, she has served as a member of the Southeastern Region Fundraising Committee, and as Kentucky District Junior Director, Junior Secretary/Treasurer, District Secretary/Treasurer, and Vice Governor.

As Kentucky Director of Junior clubs for two terms, Missi focused first on public affairs and then on veterans' issues. Among her honors is her selection as Outstanding Junior Clubwoman for Kentucky in 1994.

Born and raised in Eastern Kentucky, Missi earned her paralegal degree from Marshall University. Due to her involvement in her community she was chosen for the Ashland Community

2010 OFWC Convention

Can I Vote? And Am I a Delegate or Delegate-at-Large?

Sometimes clubwomen attending the State Convention are required to vote on an issue, motion, slate of officers, etc. It is important that each person know whether she is a voting delegate when completing the registration form for Convention.

Listed below are those persons who are entitled to vote and their specific designation (i.e. delegate, delegate-at-large).

DELEGATES-AT-LARGE

- 1. OFWC Board of Directors and Junior Board.
- 2. Those having served in elective offices at state or district level (i.e. state officers, district president, or district director of juniors).
- 3. Officers and chairmen of the General Federation of Women's Clubs residing in Ohio.
- 4. All current State Department and Division Chairmen and current District Chairmen.
 - 5. All members of Standing and Special Committees.
- 6. Trustees of all funds and *The Buckeye Magazine* staff. NOTE: Those members listed above are separate from the Delegates below. It is possible that several members of your club are eligible to vote if you have members who are in the Delegate-at-Large category plus your actual club delegate(s).

DELEGATES

- 1. Each per capita club of 25 members or less is entitled to ONE delegate (or her alternate).
- 2. Each per capita club of 26-50 members is entitled to TWO delegates (or their alternates).
- 3. Each per capita club of 51-75 members is entitled to THREE delegates (or their alternates).
- 4. Clubs with more than 75 members are entitled to a delegate for each additional 50 members up to a membership of 1,200.
- 5. Direct members may meet at each Convention and elect one delegate who is also a Direct Member to represent them.
- 6. Each City-County Federation of 10 clubs or less is entitled to TWO delegates and an additional delegate for every 20 additional member clubs.

The club membership numbers are the numbers of members a club paid dues for by December 31. If you are in doubt, contact your District President as she received the information from the OFWC Treasurer.

Any Delegate or Delegate-at-Large has only one vote even though she may report for more than one club, or be, for example, a district chairman as well as a club president.

If you are not a Delegate or a Delegate-at-Large, you will check the "Non-Voting Member" line on the registration form.

Proposed Amendments to the Bylaws of the GFWC/Ohio Federation of Women's Clubs

ARTICLE I MEMBERSHIP Section 4. Termination of Club Membership

CURRENT BYLAW: a. Any Club wishing to withdraw from GFWC/Ohio Federation of Women's Clubs must announce to its membership that a vote will take place at a designated meeting. This announcement must be made at the preceding meeting and in a mailing to each member at least one month prior to the vote. At the same time, this announcement must also be made to the State President, the District President, and the State Membership Chairman. If the club is a Junior Club or Juniorette Club, this announcement must also be made to the State Director of Junior Clubs, the District Director of Junior Clubs, and the Assistant Director of Junior Clubs.

PROPOSED AMENDMENT:

3rd and 4th sentences – strike "made" and insert "sent"

TO READ IF AMENDED:

a. Any Club wishing to withdraw from GFWC/Ohio Federation of Women's Clubs must announce to its membership that a vote will take place at a designated meeting. This announcement must be made at the preceding meeting and in a mailing to each member at least one month prior to the vote. At the same time, this announcement must also be sent to the State President, the District President, and the State Membership Chairman. If the club is a Junior Club or Juniorette Club, this announcement must also be sent to the State Director of Junior Clubs, the District Director of Junior Clubs, and the Assistant Director of Junior Clubs.

RATIONALE: State President, District President and State Membership Chairman need to receive the same announcement that the club is sending to its members

ARTICLE I MEMBERSHIP

Section 4. Termination of Club Membership

CURRENT BYLAW: b. If five or more members choose to remain a federated club, they would have the rights and privileges to the name and property of the club including funds and would remain the federated club.

PROPOSED AMENDMENT:

Strike current Section 4b and insert new Section 4b

TO READ IF AMENDED:

b. If 25% of the per capita members (those members for whom the club submitted dues to GFWC/Ohio Federation of Women's Clubs) or five (5) per capita members, whichever is more, choose to remain a Federated club, they would have the rights and privileges to the name and Federation property (i.e., directories, manuals, brochures, awards and all items pertaining to Federation membership) of the club, including funds donated

to the club for Federation projects, plus a proportionate share of all general operating funds and would remain the Federated club.

RATIONALE: Those voting to stay in Federation should have all materials gained by that Federated club, and they should have a proportionate share of monies in the general fund that they helped to raise.

ARTICLE I MEMBERSHIP

Section 4. Termination of Club Membership

CURRENT BYLAW: c. A two-thirds (2/3) affirmative vote of the entire club membership is necessary to withdraw from GFWC/Ohio Federation of Women's Clubs. The vote shall be taken by paper ballot. Each member must sign the register of eligible voters when she casts her ballot. If the ballot is submitted by mail, her signature shall be submitted on a separate paper.

PROPOSED AMENDMENT:

Strike current Section 4c and insert new Section 4c

TO READ IF AMENDED:

c. A seventy-five (75) percent affirmative vote of the entire club per capita membership is necessary to withdraw from GFWC/Ohio Federation of Women's Clubs. The vote shall be taken by paper ballot. Each member must sign the register of eligible voters when she casts her ballot. If the ballot is submitted by mail, her signature shall be submitted on a separate paper and then attached to the register. Only members affected by the decision should be a part of the decision-making process. If the club has sustaining members or honorary members who are no longer per capita members, they shall not vote.

RATIONALE: To make the numbers consistent (25% and 75%) and again indicate per capita members and to clarify voting eligibility.

ARTICLE II OFFICERS AND DISTRICT OFFICERS

CURRENT BYLAW: Section 1. The officers shall be a President, a First Vice-President, a Second Vice-President, a Secretary, a Treasurer, and a Director of Junior Clubs.

There shall be an Assistant Director of Junior Clubs. The Assistant Director of Junior Clubs shall be a member of an active Junior Club.

There shall be a District President in each District and a Director of Juniors in those districts in which there are Junior clubs.

Proposed Amendments to the Bylaws continued

PROPOSED AMENDMENT:

Insert a 4th paragraph

TO READ IF AMENDED:

Section 1. The officers shall be a President, a First Vice-President, a Second Vice-President, a Secretary, a Treasurer, and a Director of Junior Clubs.

There shall be an Assistant Director of Junior Clubs. The Assistant Director of Junior Clubs shall be a member of an active Junior Club.

There shall be a District President in each District and a Director of Juniors in those districts in which there are Junior clubs.

All elected officers, state as well as district, shall be per capita members in order to serve GFWC/Ohio Federation of Women's Clubs.

RATIONALE: To ensure that all elected officers are per capita members.

ARTICLE II OFFICERS AND DISTRICT OFFICERS

Section 9. The Treasurer

CURRENT BYLAW: d. The books of the Treasurer shall be audited at the close of each year of the administration by a Certified Public Accountant appointed by the Executive Committee.

PROPOSED AMENDMENT:

Strike "d" and insert new "d"

TO READ IF AMENDED:

d. The books of the Treasurer shall be audited at the close of each odd-numbered fiscal year. At the close of each even-numbered fiscal year, the books shall undergo a Review. Both the Audit and the Review shall be conducted by a Certified Public Accountant appointed by the Executive Committee.

RATIONALE: OFWC'S current auditor has assured us that a "Review" is a universally accepted term for a procedure that is one level down from a full audit. The "Review" would save GFWC/Ohio Federation of Women's Clubs money every other year.

ARTICLE VI DISTRICTS Section 3. District Meetings

CURRENT BYLAW: c. The General clubwoman and the Junior clubwoman receiving the highest number of votes in their respective categories shall be elected. The third member and the alternate shall be the clubwomen receiving the next highest number of votes.

The duties of this committee shall be to begin immediately to seek qualified candidates and at the next District Fall Conference, present a nominee for District President and a nominee for District Director of Juniors if the District has Junior clubs. This committee shall serve until the names of such candidates have been placed in nomination. If there is a resignation of a District President and/or District Director of Juniors after election, but before installation, the District Nominating Committee shall select another nominee and a special election shall be held at Legislation Day. If a resignation is submitted between Legislation Day and Annual Meeting (Convention), the vacancy is to be filled by the current Executive Committee with the approval of the Board of Directors.

d. The District President and District Director of Juniors shall be elected by ballot at the Fall Conference preceding the biennial election of officers of the GFWC/Ohio Federation of Women's Clubs. In case there is but one candidate for the office, the election may be by voice. They shall be installed at the same time as the GFWC/Ohio Federation of Women's Clubs officers and assume office at the end of the Annual Meeting (Convention).

e. At each District Legislation Day held in the spring of the odd-numbered years, the District shall elect by ballot a per capita member and an alternate to serve on the GFWC/Ohio Federation of Women's Clubs Nominating Committee. The District President, District Director of Juniors, District President-Elect, District Director of Juniors-Elect or any other person in the district serving GFWC/Ohio Federation of Women's Clubs in an elected capacity shall not be eligible for election to this committee. No member shall serve two consecutive terms on this committee. The District President shall send to the GFWC/Ohio Federation of Women's Clubs President and The Buckeye Magazine editor the name, address, electronic mail address and phone number of the member and the alternate within two weeks of the election.

f. When additional Districts are created in accordance with Article VI, Section 1, the State Nominating Committee shall nominate a District President for each new District and a District Director of Juniors if the District has Junior clubs. This method shall be used for the Districts first administration only.

These district officers shall be installed and assume office at the same time as the GFWC/Ohio Federation of Women's Clubs officers.

When fewer Districts are indicated, the District Nominating Committees elected prior to redistricting shall work jointly (in the newly created geographic areas) to present a nominee for a District President and a nominee for a District Director of Juniors, if there are Junior clubs in the area.

Each District Nominating Committee member shall serve on the nominating committee of the District in which her per capita club is located. (See Article VI, Section 3b.)

Proposed Amendments to the Bylaws continued

- g. Those eligible to vote at a District Conference shall be:
- a District President and District Director of Juniors.
- b Members of the District who have served or are now serving the GFWC/Ohio Federation of Women's Clubs in elective office.
- c Members of the District who are serving as State Chairmen of Departments and Divisions.
- d State Chairmen and members of Standing and Special Committees living in the District.
- e District Chairmen and the District Secretary.
- f Trustees of Special Funds residing in the District.
- g Each club in active membership in the District and each Federation in the District shall be entitled to one vote, that of the President or her alternate.
- h One delegate who is a Direct Member elected by the Direct Members of the District.
- i No member shall be entitled to more than one vote.

PROPOSED AMENDMENT:

Delete 2nd paragraph and insert re-lettered new paragraphs "d," "e" and "f"

Re-letter old "d" to "g"

Re-letter old "e" to "h"

2nd sentence of section "h" Strike "District President-elect" and "District Director of Juniors-elect"

TO READ IF AMENDED:

- d. Duties of the District Nominating Committee:
- 1. Immediately following elections of the District Nominating Committee, the District President will announce the procedures and eligibility requirements for interested candidates.
- 2. Chairman will contact members of the committee and arrange a meeting either in person, by phone or electronic methods.
- 3. The committee may want to consider current and past district chairmen as well as current and past club presidents or past district officers.
- 4. Present a slate of candidates for district President and District Director of Juniors (if the district has Junior clubs) at Fall Conference in the odd-numbered year.
- e. Eligibility of Candidates:
- 1. Candidates for the office of District President and District Director of Juniors shall be active members of a per capita club, should have served as a club president, district or state chairman.
- 2. They shall be familiar with Federation and the District as well as the duties of the District President and District Director of Juniors.
- 3. Both candidates shall be able to attend all GFWC/Ohio Federation of Women's Clubs Annual Meetings (Convention) and Board of Directors or Junior Board of Directors meetings to represent their district, bringing back pertinent information.
- 4. Both candidates shall understand that they will be responsible for working with district chairmen and Dean of Departments on annual club reports.

- f. If there is a resignation of a District President or District Director of Juniors after election, but before installation, the District Nominating Committee shall select another nominee and a special election shall be held at Legislation Day. If a resignation is submitted between Legislation Day and the Annual Meeting (Convention), the vacancy is to be filled by the current Executive Committee with the approval of the GFWC/Ohio Federation of Women's Clubs Board of Directors.
- g. The District President and District Director of Juniors shall be elected by ballot at the Fall Conference preceding the biennial election of officers of the GFWC/Ohio Federation of Women's Clubs. In case there is but one candidate for the office, the election may be by voice. They shall be installed at the same time as the GFWC/Ohio Federation of Women's Clubs officers and assume office at the end of the Annual Meeting (Convention).
- h. At each District Legislation Day held in the spring of the odd-numbered years, the District shall elect by ballot a per capita member and an alternate to serve on the GFWC/Ohio Federation of Women's Clubs Nominating Committee. The District President, District Director of Juniors or any other person in the district serving GFWC/Ohio Federation of Women's Clubs in an elected capacity shall not be eligible for election to this committee. No member shall serve two consecutive terms on this committee. The District President shall send to the GFWC/Ohio Federation of Women's Clubs President and The Buckeye Magazine editor the name, address, electronic mail address and phone number of the member and the alternate within two weeks of the election.
- i. When additional Districts are created in accordance with Article VI, Section 1, the State Nominating Committee shall nominate a District President for each new District and a District Director of Juniors if the District has Junior clubs. This method shall be used for the Districts first administration only.

These district officers shall be installed and assume office at the same time as the GFWC/Ohio Federation of Women's Clubs officers.

When fewer Districts are indicated, the District Nominating Committees elected prior to redistricting shall work jointly (in the newly created geographic areas) to present a nominee for a District President and a nominee for a District Director of Juniors, if there are Junior clubs in the area.

Each District Nominating Committee member shall serve on the nominating committee of the District in which her per capita club is located. (See Article VI, Section 3b.)

- j. Those eligible to vote at a District Conference shall be: (note: letters of following
 - changed to numbers, can't have letters following letters)
- (1) District President and District Director of Juniors.

Proposed Amendments to the Bylaws continued

- (2) Members of the District who have served or are now serving the GFWC/Ohio Federation of Women's Clubs in elective office.
- (3) Members of the District who are serving as State Chairmen of Departments and Divisions.
- (4) State Chairmen and members of Standing and Special Committees living in the District.
- (5) District Chairmen and the District Secretary.
- (6) Trustees of Special Funds residing in the District.
- (7) Each club in active membership in the District and each Federation in the District shall be entitled to one vote, that of the President or her alternate.
- (8) One delegate who is a Direct Member elected by the Direct Members of the District.
- (9) No member shall be entitled to more than one vote.

RATIONALE: We need to have District Nominating Committee procedures in place so that the same procedure is followed by all districts.

ARTICLE X NOMINATIONS AND ELECTIONS Section 2 a

CURRENT BYLAW: a. The member-at-large shall act as temporary chairman and receive all letters of recommendation for the eligible candidates.

PROPOSED AMENDMENT:

Insert new sentence at end of current a.

TO READ IF AMENDED:

a. The member-at-large shall act as temporary chairman and receive all letters of recommendation for the eligible candidates. Said member-at-large shall remain a member of the Nominating Committee, whether or not she is elected to serve as chairman.

RATIONALE: Clarification to assure that the temporary chairman member-at-large elected by the Board of Directors be specified as a member of the State Nominating Committee.

ARTICLE XI SCHOLARSHIPS Section 2. Scholarship Trustees

A. ANNETTE PHELPS LINCOLN SCHOLARSHIP TRUSTEES

Strike Section Heading: "A. ANNETTE PHELPS LINCOLN SCHOLARSHIP TRUSTEES"
Re-letter Section "B" to "A"

TO READ IF AMENDED:

A. GFWC/OHIO FEDERATION OF WOMEN'S CLUBS SCHOLARSHIPS

RATIONALE: Due to the inclusion of APL into the Board of Trustees Scholarships, there is no longer a need for "A."

OTHER ARTICLES REVIEWED: Proposed 2009 amendments sent back to Bylaws Committee for further study:

ARTICLE I MEMBERSHIP Section 6. Direct membership

It is the recommendation of the Bylaws Committee to send to the Board of Directors of GFWC/Ohio Federation of Women's Clubs for its review/action.

RATIONALE: An amendment regarding Direct Membership was returned to committee at the 2009 Convention for further study. The suggestion came from Patrice Booze that we delete the "Direct Membership": category (Article I Membership, Section 2-d) and set up a "Statewide Members at Large (per capita) Club." Her intent, we believe, is that it be an actual per capita club whereby all former Direct Members would then be entitled to vote at district or state meetings and also serve as district or state officers/chairmen since they would then be per capita members.

It is the consensus of the Bylaws Committee that this be studied further and that the Board of Directors conduct a survey of the current Direct Members to see if this is even what they want. Quite a few of the Direct Members don't come or are not able to come to district or state meetings; however, they do like to receive the Buckeye to keep abreast of what is going on in GFWC/Ohio Federation of Women's Clubs.

ARTICLE VII DUES Section 6.

It is the recommendation of the Bylaws Committee that the proposed amendment be sent to the Board of Directors of GFWC/ Ohio Federation of Women's Clubs for review/action.

RATIONALE: Section 6, which was a recommendation that the Direct Members dues be increased to \$25.00 (twenty-five) was referred to the Bylaws Committee at the 2009 Annual Meeting (Convention). Dues should not be changed until the decision has been made as to whether Direct Members remain as is or they become a statewide per capita club.

Housekeeping changes needed to reflect current GFWC language.

Review Bylaws and replace all "Department" names with corresponding new "GFWC Service Program" names.

RESOLUTIONS

The following resolution has been reviewed by the GFWC/ OFWC Resolutions Committee and was submitted to the Board of Directors, which recommended that the proposed new resolution be presented to the assembly at the Annual Convention.

RESOLUTION 1-10 DRIVING AND TEXTING

WHEREAS driver distraction was fatal to 6,000 persons and injured a half million more last year, and

WHEREAS texting has been shown to be the worst distraction because of the danger when texters (those who are texting) are looking down and not devoting attention to driving, and WHEREAS text messages rose from 10 billion in 2005 to 110 billion in 2008, and

WHEREAS one in four people admitted to texting while driving, and 46 percent of teenagers say they text while driving, and WHEREAS 18 states have passed laws making texting while driving illegal, and

WHEREAS some Ohio counties and cities like Summit County and Cleveland have bans against reading or sending texts, and WHEREAS bills have been introduced in the Ohio House of Representatives (HB 270) and the Ohio Senate (SB 160) to ban texting while driving statewide, therefore,

RESOLVED that members of the GFWC/Ohio Federation of Women's Clubs contact their state legislators to advocate for the passage of these bills for statewide coverage, and further RESOLVED that GFWC/OFWC members educate other community members and increase their awareness of the dangers of driving while texting and encourage them to contact their legislators to urge passage of the bills.

PROPOSED FOR AMENDMENT

The following resolutions were reviewed by the Resolutions Committee and submitted to the Board of Directors which recommended that the following amendments (IN BOLD FACE TYPE) be presented to the assembly at the Annual Convention.

Resolution 2-78 RECLAIMING DECENT VALUES IN FAMILY TELEVISION

(Reaffirmed 1983 & 1988; Reviewed 1992 & 1996; Amended 2000, 2001, Reviewed 2006, 2010)

WHEREAS, There are **162.8** million U. S. households with television and **41.7** million of these house children ages 2 to 11, and

WHEREAS, Surveys show that the average American youth watches 1,500 hours annually, this figure is considerably higher than the time they spend participating in sports, in church, in school, or in learning situations with their parents; and

WHEREAS, An increase in the number of reported violent acts directed at children, and an increase in the amount of severity of violent acts observed by children through the media have led to a strong standing concern with the impact of television on behavior especially on children that it is now considered a public health problem by the AMA, and

WHEREAS, On network television, violence before nine o'clock p.m. has decreased; however, implicit and explicit sexual vulgarity and sensationalism on cable, in programming and advertising, have increased; and

WHEREAS, This vulgarity and suggestiveness particularly in commercials presents itself without the opportunity for parental monitoring; therefore

RESOLVED, That the GFWC/Ohio Federation of Women's Clubs strongly oppose this type of "family entertainment" and recommends that the Federal Communications Commission, the national television networks, and the sponsors of such programs and commercials strive to present viewing which is healthy and stimulating entertainment for the entire family and elevating to the minds and speech of America's youth; and further RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urges members to write to the presidents of sponsoring companies and/ or organizations and television and cable executives requesting their help in reclaiming decency for the good of our country.

Resolution 1-95 PROSTATE CANCER SCREENING (Amended 1999; Reviewed 2003, 2007)

WHEREAS, One in 6 men has prostate cancer in some form by the age of fifty, but only 1 in 35 will die from it, and WHEREAS, While thirty percent of those curable were detected by DRE (Direct Rectal Examination), the cure rate

RESOLUTIONS

increases to 80 percent by the concurrent use of PSA (Prostate Specific Antigen) blood testing; therefore RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urge its members to encourage their male friends and relatives to obtain annual DRE's and PSA's beginning at the age of fifty (or as recommended by their physicians), encourage proactive measures by continuing to monitor their PSA for signs of trouble; and further RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urge member clubs to become involved in community education (formally and/or informally) about the importance of DRE and PSA testing. Members are encouraged to form a coalition with hospitals and the cancer society to present programs, promote testing opportunities, and form support groups for prostate cancer patients and for their relatives and friends.

Resolution 2-95 BREAST CANCER SCREENING (Reaffirmed 1999, Amended 2003, 2007)

WHEREAS, 2.4 women in the United States have been diagnosed with breast cancer, and breast cancer is the most common cancer among U.S. women and accounts for 1 out of every 4 women diagnosed, and 192,370 more women will be diagnosed this year, and an estimated one million are unaware that they have the disease; and

WHEREAS, Breast cancer is the second leading cause of cancer death for women in the United States between the ages 20 to 59, a woman in the United States has a 1 in 8 chance of developing invasive breast cancer during her life time; and the chance that breast cancer will be responsible for a woman's death is now 13%. Death rates from breast cancer are declining significantly with the largest decreases in young women; this is attributed to early detection and more effective treatment; and

WHEREAS, About seventy-seven percent of breast cancers occur in women ages 50 and over, and although less than five percent of all breast cancer occurs in women under the age of 40, younger women who develop breast cancer have a lower survival rate; and

WHEREAS, Mammogram screening does not prevent or cure breast cancer; however it may detect the disease before symptoms occur because breast cancer can exist 6 to 10 years before the growth can be detected; therefore

RESOLVED, That the GFWC/OFWC urge each member to learn and practice monthly self-breast examinations and to have clinical breast examinations every three years for women 20 to 39 and every year for women 40 years old or over upon the recommendation of their physicians; and further RESOLVED, That the GFWC/OFWC encourage women 40 years old and over to continue with mammograms upon the recommendation of their physicians; and further

RESOLVED, That the GFWC/OFWC encourages its members and other women to continue self-breast examinations as a way to reduce risk factors and to follow medical community guidelines for finding cancer early since it is non-invasive, does not cost anything, and has been effective in some instances.

Resolution 3-95 DISASTER PREPAREDNESS (Reaffirmed 1999, Amended 2002, Reviewed 2006)

WHEREAS, Disaster, natural or manmade, can strike a home or community at any instance; and

WHEREAS, Due to lack of emergency preparedness plans and guidelines which cause confusion and ignorance can increase morbidity and mortality; therefore

RESOLVED, that the GFWC/Ohio Federation of Women's Clubs urge its member clubs and members to:

- 1) Encourage and participate with their communities to form and/or review existing disaster plans for accuracy and timeliness
- 2) Support training of community employees, rescue and relief workers, as needed
- 3) Advocate for communication and coordination of efforts between hospitals, governmental and public safety agencies
- 4) Support public education and publication of the disaster plan; and further

RESOLVED, the GFWC/Ohio Federation of Women's Clubs urges its members to form and/or review existing emergency preparedness plans for their own households.

Resolution 1-99 ORGAN DONATION (Amended 2002, 2007)

WHEREAS, according to Lifeline of Ohio, a non-profit organization which promotes organ donations, there were 100,000 individuals on the national waiting list for an organ transplant as of December 2009; and

WHEREAS, on the average 18 individuals (men, women and children) on the national waiting list die each day while waiting for a transplant; and

WHEREAS. One donor can save or improve the lives of 7 individuals awaiting organ transplants and 35-50 awaiting tissue transplants; and

WHEREAS, 90% of Americans say they support organ donation but only 30% sign up to do this; therefore

RESOLVED, that the GFWC/Ohio Federation of Women's Clubs urges its member clubs to present programs to educate members and the public on the benefits of organ donation, answer questions concerning donations, and to learn how to become a donor.

PROPOSED FOR AMENDMENT

Resolution 2-99 HABITUAL SEXUAL OFFENDERS AND SEXUAL PREDATORS

(Reviewed 2003; Amended 2007)

WHEREAS, Sexual predators and habitual sex offenders pose a high risk of engaging in further offenses, even after a risk assessment during the reception process; therefore, after being released from imprisonment, or other confinement, the protection of members of the public from sexual predators and habitual sex offenders should be of paramount interest; and

WHEREAS, Under current Ohio law there are definite prison terms required for sexually related offenses, but mandatory treatment is not required; therefore RESOLVED, That the GFWC/Ohio Federation of Women's Clubs urge our legislators to support reforms dictating released offenders be on parole for life, with active monitoring by a parole officer, and mandatory ongoing treatment requirements as a condition of that parole. Parole officers assigned to this duty should have specialized training in the psychology of the sexual offender, and should have the ability to incarcerate defendants for any failure to cooperate with either monitoring or treatment; and further

RESOLVE, Any defendant convicted of a sexual offense involving children, no matter how minor, should be restricted for life from participating in any occupation or volunteer activity which involves supervision of children. This should be a separate criminal offense, with a mandatory sentence, so that the onus is on the convict, not on the community.

Resolution 1-02 SAFER SKIES/DOMESTIC AIRLINE TRAVEL (Reviewed 2006)

WHEREAS, The United States of America is no longer safe from attacks by terrorists and saboteurs; and

WHEREAS, Airports are currently installing new scanning technology not only for baggage and cargo but also for passengers. These new scans which range from full body scans, patdown searches, iris scans, three dimensional photos, microchip embedded passports, machines which blow a puff of smoke to detect explosives, and

WHEREAS, All checked and carry on luggage is now scanned and/or hand searched, and

WHEREAS, The government is now establishing a safer and more efficient air traffic system, improvement to the New Air Navigation System, and improved airports in order to provide safe airline travel; therefore

RESOLVED, that the GFWC/Ohio Federation of Women's Clubs asks its member clubs to urge their legislators to make it

compulsory for all domestic flights to screen all checked luggage for explosives and other dangerous materials before being loaded onto the airplane.

Resolution 3-02 SUPPORT OF THE WAR AGAINST TER-RORISM

(Reviewed 2006)

WHEREAS, Global terrorism poses a grave danger to the security of all nations, including that of the United States of America and to the safety of Americans at home and abroad; and

WHEREAS, The information technology revolution has changed the way business is transacted, the way government operates and the way national defense is conducted; and WHEREAS, George W. Bush, **former** President of the United States of America, has declared that a national emergency by reason of certain terrorist attacks has existed since September 11, 2001; and

WHEREAS, Americans have been asked by President Bush to come together to confront the threat of terrorism; therefore RESOLVED, that the GFWC/Ohio Federation of Women's Clubs urges its member clubs to assist in the war against terrorism by supporting the government of the United States of America at all levels by;

- 1) Supporting the efforts of the Office of Homeland Security, which includes Cyberspace Security
- 2) Supporting the victims of terrorist attacks
- 3) Supporting Americans in uniform
- 4) Participating in the American economy, and
- 5) Upholding and living the values and principles of America.
