
**AFFIDAVIT OF SCOTT HUMINSKI CONCERNING RECEIPT OF
FOLLOW-UP DEATH THREAT of 5/4/2015 TARGETING HUMINSKI
FOR PARTICIPATION IN THIS APPEAL**

NOW COMES, Scott Huminski ("Huminski"), and, swears, states, deposes, affirms, under oath, and as follows:

1. Attached hereto as Exhibit "A" is a true and correct copy of the follow-up to the death letter (received 4/2/2015) which is another threatening letter targeting myself for participation in this appeal. True and correct copies of the envelope and photograph contained along with the letter are reproduced in Exhibit "A".
2. Exhibit "A" was mailed (postmarked) on 5/4/2015 and received by me on the same day.
3. The postmark indicates the author has travelled to the town of my residence in Florida to terrorize and intimidate me concerning participation in this appeal and the matter in the Court below.
4. A picture of my home was also included in the 5/4/2015 letter which has caused me to be greatly intimidated, distressed and terrorized knowing that the killer knows the exact location to commit the murder.
5. I believe the 5/4/2015 letter was filed as direct retaliation for the filing of this appeal, as the author clearly stated his problem with my use of the United States Courts for redress of grievances, his threats extend to this appeal. Upon information and belief, Exhibit "A" is a proximate retaliatory response to the filing of this appeal.

6. Upon information and belief, the photograph received by Huminski of his home came from google earth and there exists computer forensic data concerning the visit to google earth.
7. Upon information and belief, the postmark from Exhibit "A" indicates that the exhibit was mailed from a customer counter at the U.S. Post Office in Bonita Springs and that forensic video evidence exists concerning the mailing of the letter of 5/4/2015.
8. I am terrorized and intimidated by the knowledge that the alleged killer is now located in the town of my residence.
9. Upon information and belief, forensic evidence may exist at the residence of the author of the two death threats issued in this case including matching envelopes, stamps, paper, adhesive labels and other evidence related to the generation and mailing of the death threats.
10. Upon information and belief, the author of the death threats issued the second letter when he learned that the federal courts were powerless to stop crimes and torts related to obstruction of justice targeting the federal courts as held by the U.S.D.C (Conn.).
11. I suspect Ryan Pillar or Trevor Nelson to be the author of the death threats.
12. Upon receipt of the death threat of 4/2/2015, Huminski contacted Mark Cavic of the U.S. Postal Inspection Service who took the first death threat letter into evidence and gave the Lee County Sheriff's Department custody of the 5/4/2015 letter and alerted the U.S. Marshall's Service who have shown an interest in the case.

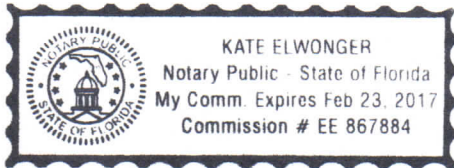



The above was a .jpg attached to Nelson's email, after I received two death threats in the mail, I Authored the teaser to flush out the killer.

Throughout 2015-2016 Nelson had been publishing Huminski's writings of docfoc and had also followed Huminski to various websites such as justice4vinny claiming that he was my neighbor in Florida. Full send strings available for all emails.

Dear Senators and Representatives,

I write this letter with a heavy heart knowing that the terrible shootings and murders that took place in Tucson this year are destined to repeat without proper legislation.

Months after the Tucson tragedy email threats of violence and death were sent to myself and my wife. Law enforcement in the Town of Gilbert, Arizona and the City of Surprise, Arizona classified the emails as acceptable, lawful and proper.

A State authorized mental health provider, Urgent Psychiatric Care of Phoenix, Arizona, found the emails represented imminent probability of harm to the targets of the emails and issued a police pickup order for an involuntary mental evaluation of the author of the emails, Justin Michael Nelson.

Egregiously, the City of Surprise, Arizona refused to pick up Mr. Nelson for several (4) days until they were forced to attempt pickup of Mr. Nelson. At that point they made what was described as half-hearted "pseudo-attempts" to pickup Mr. Nelson while high ranking City Attorneys in Surprise tipped off Mr. Nelson to the fact that the police were on their way.

The emails sent by Mr. Nelson originated in Surprise, AZ and were processed and forwarded to the Huminskis by Gmail (google email) of California. The emails may have traveled through other states as well. The federal government has jurisdiction over this type of interstate crime. Gilbert Police have confirmed the emails via results of a subpoena served upon

google. Some emails investigated by Gilbert Police violated a Court ordered restraining order against Nelson concerning the Huminskis, a felony in Arizona. Again Gilbert Police with undisputed and overwhelming probable cause for an arrest ignored the criminal terrorizing of the Huminskis.

They are completely in context with scores of other threatening emails from Mr. Nelson. Amazingly, the Phoenix Police are considering a prosecution of the Huminskis for forwarding the above three emails to Urgent Psychiatric Care of Phoenix. Something is deeply wrong with this after the Gabby Giffords tragedy. Criminalizing reporting of dangerous mental health issues of persons such as Jared Loughner or Mr. Nelson is a terribly misguided law enforcement policy. The Phoenix police contact with Scott Huminski investigating the "crime" of reporting the above emails to State psychiatric authorities invites non-reporting and more Tucson-style terror.

Federal Legislation

In light of an absence of effective State law to handle such issues and/or the refusal of State law enforcement to address such matters, Federal Legislation is required to regulate this interstate use of the internet for terror and hopefully prevent another Gabby Giffords type incident.

The most disturbing part of this incident was the outright refusal of law enforcement to pick up Mr. Nelson for mental evaluation when ordered by a licensed mental health facility as a result of transmittal of interstate threats. This law enforcement conduct should be a federal crime as it invites violence and murder. There was much talk of the ability to evaluate Jared Loughner prior to the shootings. This would have been futile as Arizona law enforcement obstructs such pickups as a policy, if someone did report Loughner, it would have been useless with law enforcement's outright refusal to execute mental evaluation pickups.

There should also be consideration of legislation setting parameters making it criminal for state law enforcement to ignore such interstate communications and make it mandatory for State law enforcement to report such terror-style internet communications to federal authorities for review and prosecution. In this age of heightened security, the last thing needed is law enforcement's willing promotion or cover-up of the terrorist-style above threats by inaction. Arizona law enforcement has not learned from the Tucson tragedy. Proactive rather than reactive is the proper response to death and violence emails.

review. The arrest threat targeting litigation against police officer Bruce Hume remains looming over Huminski's head chilling civil litigation.





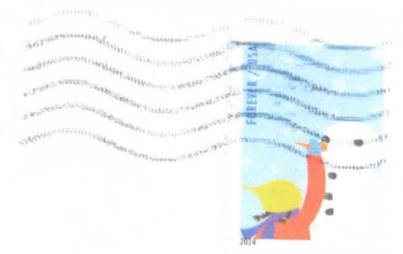
